**PRIVACY NOTICE**

Uniprom, Inc. (UI) is committed to protect and respect your personal data privacy in compliance with Republic Act No. 10173, otherwise known as the Data Privacy Act of 2012 (DPA).

1. Service Description – UI manages the leisure and entertainment ventures of the Araneta City: Smart Araneta Coliseum, New Frontier Theater, Gateway Cineplex, and Ali Mall Cineplex. UI is also the organizer and/or promoter of the 2025 Binibining Pilipinas Beauty Pageant that is scheduled to held in the second quarter of the year at the Smart Araneta Coliseum (“2025 Pageant”).
2. Personal Information that are Collected – UI collects the following personal data from you: (a) name, nickname, stage name; (b) photographs; (c) date of birth; (d) place of birth; (e) past/present address/es; (f) sex/gender; (g) citizenship; (h) body measurements (height, weight, bust, waist, hips); (i) medical and psychological information; (j) hair and eye color; (k) names of parents/guardian; (l) landline and/or mobile number; (m) email address; (n) passport details; (o) educational background; (p) past/present occupation; (q) details of past/existing contracts for talent management and similar agreements; (r) hobbies, sports activities, talents, skills; and (s) past Beauty Pageants joined (collectively, the “Personal Information”).
3. Collection Method – UI collects the Personal Information by manually gathering the Official Application Form (in questionnaire format) and other documents (i.e. birth certificate, diploma, passport, valid government ID, medical and psychological certificates) that you submit physically and/or digitally in support of your application to participate in the 2025 Pageant.
4. Timing of Collection – The Personal Information is collected the moment you submit the Official Application Form and the other documents (i.e. birth certificate, diploma, passport, valid government ID, medical and psychological certificates).
5. Purposes of Collected Personal Information – The Personal Information will be used by UI for the purposes of: (a) determining and evaluating your fitness and eligibility to join and participate in the 2025 Pageant; (b) providing you marketing and/or promotional information on the products and services that UI and its Affiliates (ACI, Inc., PPI Holdings, Inc., Araneta Hotels, Inc., Binibining Pilipinas Charities, Inc., Ticketnet, Inc., and Progressive Development Corporation) are offering, in order to help UI and its affiliates to create, develop, deliver, and improve their products and services; and (c) opening prospective employment opportunities for you.
6. Storage and Transmission of Personal Information – The physical/printed copy of the Official Application Form and all other documents that you provide shall be filed and kept in a locked cabinet, accessed only by a limited number of individuals. Any transportation/transmittal of the Official Application Form and other documents shall be made physically within the confines of UI’s office.
7. Method of Use – The Personal Information will be used as-is and will be summarized in order to determine your fitness and eligibility to join and participate in the 2025 Pageant.
8. Location of Personal Information – The Official Application Form and all other documents that you submit shall be stored inside UI’s office at the 8th Floor Aurora Tower, Araneta City, Quezon City.
9. Third-Party Transfer – The Personal Information will not be transferred to any third-party for further processing.
10. Retention Period – The Official Application Form and other documents shall be kept in storage for as long as necessary to the purpose of the Consent, unless otherwise provided for by existing applicable laws and regulations.
11. Participation of Data Subject – Your rights as data subject under the DPA are the: (a) right to be informed; (b) right to access; (c) right to object; (d) right to erasure and blocking; (e) right to rectify; (f) right to file a complaint; (g) right to damages; and (h) right to data portability.
